- 6. (2) An Approved Assessor shall not perform any functions under these Regulations where the same concern any person or body with which the said assessor has had any professional, business or commercial relationship within the period of five years commencing on the day of the termination of any such relationship."

Please also note that the terms and conditions, actual and implied, of engagement of an Approved Assessor are matters for the parties to the contract of engagement.
